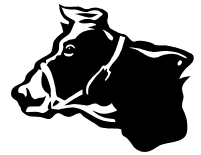

2) Failure to reimburse Wisconsin State Fair will result in being barred from exhibiting cattle or participating in other Wisconsin State Fair events. This will include members of partnerships.

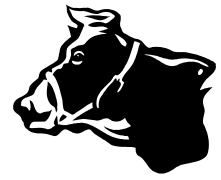
