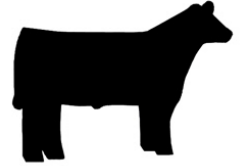

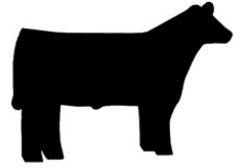

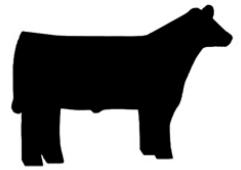

Attention Open Class Beef Exhibitors!

As you read in the 2011 Wisconsin State Fair Open Beef entry information the Fair is no longer offering common bedding for the open class beef shows. This tough decision was made to control increasing program costs and ease the transition from the junior beef show to the open beef shows. This change reduces the entry fee from \$25 to \$10 per animal and should allow exhibitors an earlier opportunity to enter the barn for set-up on Thursday evening August 11th.

In discussions with some exhibitors over the past few months we have been asked if the common bark bedding from the junior show could be left in the stalls for open class beef exhibitors to use for a bedding pack. We have identified a procedure to accommodate those who would like to stall on bedding from the previous show. Wisconsin State Fair will make a reasonable effort to clean bark areas of trash and other debris at the completion of previous show. Note: there is no charge for stalling on bedding from the previous show

Wisconsin State Fair will not provide loading or unloading services for any bulk orders coming from outside vendors or movement of bedding products. The Wisconsin State Fair Feed and Bedding Department will have straw or shavings available for sale on the Fairgrounds. Orders may be made in advance of the Fair or upon arrival; please note orders need to be placed 12 hours before delivery.

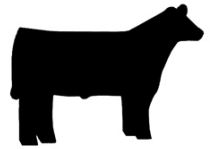
